At the outset, Dr. H Basavanagowdappa, I/c Vice Chancellor invoked the blessings of His Holiness Jagadguru Sri Shivarathri Rajendra Mahaswamiji, the founder President of JSS Mahavidyapeetha and submitting respectful pranams to His Holiness Jagadguru Sri Shivaratri Deshikendra Mahaswamiji, Hon'ble Chancellor and extended a warm welcome to



all the members to the 50th meeting of the Board of Management. He mentioned that this meeting as the Golden Jubilee BoM (50th) Meeting of JSS Academy of Higher Education &

Research. He said that two of the hon'ble members of the Board of Management, viz. Dr. V M Katoch and Dr. Girish Shah had expressed their inability to attend the meeting and have requested the leave of absence.

Recalling the journey of 11 years of JSS AHER, the I/c Vice Chancellor thanked all the hon'ble members of the Board of Management for having guided to achieve many coveted accreditations and laurels. All these accolades and achievements have made the Deemed to be university proud nationally and internationally. He placed on record the committed contributions of Dr. B. Suresh -who completed 11 successful years of leadership as VC and has been mainly responsible for all the accolades & achievements of the Deemed to be University. With his visionary leadership the institution was accredited by NAAC:A+, ranked by NIRF among top 50 universities in India and also featured in THE rank band of 401-501 in world University rankings and scaled to Category-I status by UGC. He requested the members of the Board of Management to felicitate Dr. B Suresh for having assumed the position of Pro-Chancellor of JSS AHER.

Hon'ble Justice Sri Shivaraj Patil, speaking at this juncture said that working as Vice Chancellor for two terms and for more than a decade is a great milestone. He termed the leadership of Dr. B Suresh as dynamic and congratulated him for being appointed as Pro-Chancellor. The members felicitated Dr. B Suresh and placed on record the excellent services rendered by him as the Vice Chancellor of JSS AHER for 11 years and wished that he will continue to guide the Deemed to be University further in the capacity of Pro-Chancellor.

Dr. B Suresh, Pro-Chancellor submitted his respectful and humble pranams to His Holiness Swamiji, thanked the members for felicitating him and said that these achievements were possible because of the dynamic leadership and governance provided by the members of the Board of Management both- past and present and thanked all the members for their guidance, co-operation and directions in steering the Deemed to be University during his tenure. He also thanked all the teaching and non-teaching staff who provided complete support during his tenure as Vice Chancellor.

Justice Sri Shivaraj Patil endorsed all the above points of appreciation & the good work done by Dr. B Suresh & he welcomed Dr. H Basavanagowdappa in his new capacity as I/c Vice Chancellor and wished him all the very best.

With the above opening remarks, the Vice Chancellor sought the permission of the Board of

The Vice Chancellor informed that the minutes of the 49th meeting of the Board of Management held on 29th March 2019 were circulated



and since there were no remarks received from the members, he requested to consider and confirm the minutes.

The minutes of the 49th Meeting of the Board of Management held on 29th March 2019 were confirmed.

AGENDA No-50.2 : To consider the Action Taken Report on the minutes of the 49th meeting of the Board of Management held on 29th March 2019.

Discussing the ATR on the minutes of the 49th meeting the Vice Chancellor said that Agenda 49.1 referred to the confirmation of the minutes of the 48th meeting held on 29th November 2018.

Regarding Agenda 49.2, which was the Action Taken Report on the 48th Board of Management meeting wherein the suggestion to COE by Justice Shri Shivaraj Patil and Dr. Sacchidananda to visit RGUHS and pursue digital valuation implementation was discussed and considered. It was also informed that this agenda was also placed in the Academic Council meeting of JSSAHER held on 7.8.2019 and informed the Controller of Examinations to brief members on the visit and the outcome of the same.

Dr. Sudeendra Bhat, COE thanked the Vice Chancellor of Rajiv Gandhi University of Health Sciences (RGUHS), Bengaluru for providing the oppourtunity to visit RGUHS and interact with officers of examination section regarding digital valuation system. He informed that he also visited NITTE (Deemed to be University) Mangaluru to understand the digital evaluation system implimented and its utilisation. He said that he has prepared a document containing the advantages and challenges of the digital valuation system. This was also discussed in the recently held Academic Council meeting of JSSAHER and the opinions of the mememers have been taken. Justice Sri Shivaraj Patil suggested that COE shall prepare a detailed report along with his recommendation and circulate the same to all the members of the BOM before the next meeting and the same shall be taken-up for discussion in the next BOM meeting.

Sri Sathyam suggested that the marks card should contain a

microchip, which should provide complete student's academic performace history. COE mentioned that JSSAHER is already providing marks card and certificates containing microchip, that helps in establishing the authenticity of the same. He also said that as per the directives of MHRD - National Academic Depository (NAD), which is a Government of India initiative, student's academic performace records are made available in the NAD portal.



JSS AHER is fully compliant with this directive. With regard to providing open access to data contained in the micro-chip, Prochancellor opined that the confidentiality and technical issues are the challenges.

Agenda 46.17 was regarding the increase of PhD Student ratio and as suggested by Sri Sathyam, it was informed that an analysis had been done and detailed report was prepared. Whenever drop out is noticed, counselling is being done to find out the preventable drop outs.

Agenda 46.24 was regarding re-accreditation of NAAC and that our appeal submission was considered by NAAC and which has revised the score from 3.467 to 3.476 and has rounded off to 3.48 for a period of five years from July 2019.

Agenda 49.3 related to the appointment of Vice Chancellor to JSS AHER by the Search cum Selection Committee and until a decision is made, Dr. H Basavanagowdappa, Dean, Faculty of Medicine has been nominated as the I/c. Vice Chancellor of JSS AHER.

Agenda 49.4 related to the nomination of two representatives of the Board of Management to the reconstituted Finance Committee which is adhered to.

Agenda 49.5 was the revised estimates of 2018-19 and Minutes of the 21st Finance Committee of JSS AHER and the same was taken note of.

Agenda 49.6 was the Annual audited accounts of the JSS AHER wherein investments in FD and other high interst yielding instruments were discussed. Finance Officer said that this has been discussed with Director (Finance) of JSS Mahavidyapeetha and the minimum period for investment of institutional fund in mutual fund etc is 15 years and as such the Director (Finance) JSS MVP advised to go for short term investment in FD to fetch additional revenue income in the form of interest keeping in view of the requiement of fund for the proposed Varuna Project.

Sri Sathyam mentioned that Government is in the process of making amendments in the Income tax rules subject to certain conditions and advised to ascertain from the Deemed to University statutory auditors to assess whether there was any scope for suggestions. He said that as per ICAI norms procedure to regulate the depreciation fund should be adhered to as it is also one of the mandate on the AEM (Anticipated Expenditure Management). Justice Sri. Shivaraj Patil & Sri Sathyam suggested to ascertain from the auditors whether the surplus revenue generated over the expenditure attracts any tax liability.

Minutes of the 50th Meeting of the Board of Management-14-08-2019



Agenda 49.7 was regarding approval of the Budget Estimates of JSS AHER and its constituent colleges for the year 2019-20 which is approved.

Agenda 49.8 was to consider and approve the re-apropriation of Expenditure incurred in excess of the Budget Estimates of JSS AHER for 2017-18. Sri Sathyam said that a sum of Rs. 196 lakhs unspent under Research and Development Head of A/c which is proposed to be reappropriated for other expenditure does not reflect well and suggested that while preparing the next budget to see that the allocated amount under the said head of a/c should be fully utilised for the R & D purpose.

Agenda 49.9 related to the ratification of opening of Bank accounts.

Agenda 49.10 was regarding the appointment of Auditors for JSS AHER. Ms. Madhavan & Co. have been appointed as Auditors of JSS AHER for the Financial Year 2018-19. Sri Sathyam said that in the minutes the words "have been informed" should be changed as "appointed".

Agenda 49.11 relates to categorization of JSS AHER for grant of graded autonomy under Category-I. Sri Sathyam said that no cap is indicated in the UGC new regulations and Department of Yoga, Ayurvedic Medicine and Naturopathy schools may be included under this and explore whether INYS Campus at coimbatore can evolve as another off campus of JSS AHER. Justice Sri Shivaraj Patil said that any changes made, should always comply with UGC Regulations. Even during development of Varuna campus, UGC regulations should be kept in mind and the aim should be to develop the Varuna campus appropriately. While discussing about establishment of new department at constituent colleges, Sri. Sathyam asked whether this was discussed at the governing body of the respective constituent colleges and the Academic council. Vice Chancellor (I/c) mentioned that the matter was discussed in the governing body of the respective constituent colleges and Depatrments of Deemed to be University and necessary approval/recommendation of Academic council was sought and then placed before the BOM for approval.

With regard to the Online PG Diploma certificate courses, Sri

Sathyam wanted to know whether UG/PG courses too will be offered by the OEP. Pro-Chancellor said that there are no restrictions for diploma and certificate courses. however, for UG/PG Online courses particularlyMedical/Dental/Pharmacy statutory bodies may not



approve the same. Hence, the Deemed to be University is proposing to offer PG diploma courses which is advantageous for persons employed in the industry/academia needing career advancement and as such JSS AHER has created it's own platform and not hosted on SWAYAM. With regard to query on OEP dependent on the learners contact centre, Pro-Chancellor said that OEP does not require learners contact centre.

Agenda 49.12 related to the establishment of Faculty of Sciences under MOA/Rules of JSS AHER. Vice Chancellor said that Dr Katoch had suggested to consider Faculty of Natural Sciences as the nomenclature. He informed that the said matter was placed before the Academic Council for discussion as suggested in the previous meeting. The Board approved the nomenclature of new faculty as ' Faculty of Natural Sciences'.

Agenda 49.14 was regarding the establishment of Department of Nutrition and Dietitics from the AY 2019-20. The said department which was under Water and Health Department has been separated and will be functioning under Faculty of Life Sciences.

Agenda 49.15 was the establishment of Department of Yoga and the BOM had considered and approved the same. The action is under progress and JSS AHER has interviewed faculty and recruitments will be done shortly.

Agenda 49.16 related to the establishment of Medical Genetics at JSS Medical College wherein faculty have been appointed already and this department will function from this Academic Year.

Agenda 49.17 was the starting of Online courses at JSS AHER and action is under progress.

Agenda 49.18 was regarding the minutes of 24th meeting of Academic Council and CBME has been implemented.

Agenda 49.19 was the reconstitution of various Boards of Studies of JSS AHER

Agenda 49.20 to 49.23 were regarding Adjunct faculty nominations, minutes of PhD selection committee, additional staff for HSMS Department and membership of IAU by JSS AHER which have been considered.

Agenda 49.24 was the THEs' Emerging Economies University Rankings.



Agenda 49.25 was the Food & Supplies Policy of JSS AHER and the matter has been hosted on university website and constituent colleges are also made aware of this policy.

Agenda No. 49.26 was the policy on minimizing the use of plastic products at JSS AHER. Executive Secretary suggested hosting this on the university website and measures are taken accordingly. He said the plastic should be less than 50 microns and not 20 as stated in the minutes.

Agenda 49.27 was establishment of SCOPE Hub at JSS AHER which is considered and approved.

Agenda 49.28 to 49.31 are the formal agenda on routine issues which are approved, and action initiated.

Agenda 49.32 was the MoU with Texas Southern University, USA. Justice Sri Shivaraj Patil had sought a comprehensive report of analysis of various MoUs entered by the JSS AHER and its outcomes. The Vice Chancellor briefed about the outcomes. Sri Shivaraj Patil appreciated the outcomes of the MoUs. At this juncture Dr. B N Gangadhar wanted to know how many universities/ institutions/companies have approached JSS AHER for collaboration vis-a-vis JSS AHER for approaching them. The Vice Chancellor informed that a significant number of universities/ institutions/companies have approached JSS AHER as our ranking is good & he cited the examples of iMERA, Khon-Kaen University, University of Sri Jayewardenepura, etc. The Pro Chancellor informed that many of the International projects have PI's from both universities. He also explained about the joint academic efforts regarding PhD programs with La-Trobe University, Dr. B N Gangadhar also wanted to know among the collaborative projects how many of JSS AHER Faculty are PI's and how many publications have faculty from JSS AHER as first author.

Dr. Nilani. P replied that 115 out of 222 publications have first authors from JSS AHER. Further Dr. Gangadhar sought as to how many PI are there from JSS AHER. Pro-Chancellor in reply said that these projects have PI's from both partnering universities/institutions.

Sri Sathyam wanted to know on the impact rankings wherein SDG 4 on quality teaching and enquired about the reasons for the ranking of the institution in 300 band compared to other SDG and how is that the teaching quality is reflected as low when the university is ranked high in other impact factors and requested a feedback on this. Dr. Nilani said that the matter has been discussed with the ranking



agency wherein as per SDG 3 we are not a comprehensive university whereas SDG 4 is quality education wherein one of the parameter relates to as to how technology is influencing the performance is assessed. A letter to this effect is written to them to rectify this, she said.

Agenda 49.33 to 49.38 and 49.43 to 49.46, 49.48, 49.49 and 49.54 were related to various MoUs being entered into by the JSS AHER whereas Agenda 49.39 was the renewal of Research Collaboration Agreement with Philips Electronics India ltd.

Agenda 49.40 was regarding various research projects submitted /sanctioned from various funding agencies from Nov.2018 to Feb.2019.

Agenda 49.41 was regarding appointments, resignations of teaching/non-teaching staff for the period- Nov.2018 to Feb.2019.

Agenda 49.42 was the minutes of the 22nd meeting of Finance Committee held on 25.3.2019

Agenda 49.47 was regarding Master Research Agreement with Philips Electronics India Ltd.

Agenda 49.50 was approval of amendment to Byelaws/statutes of JSS AHER which has been considered.

Agenda 49.51 was regarding the Notification of UGC Regulations 2019 and 49.52 was the brief report on the analysis of publications made by faculty of JSS AHER for the period Jan.2018 to Dec.2018. As suggested by Sri Shivaraj Patil, an analysis comparison with other universities has been done. Sri Sathyam wanted to know as to what were the factors that were looked into other than citation index & impact factor. Pro-Chancellor replied that along with citation index & impact factor, publishing in preferred journals is considered as important & first preference is given to SCOPUS indexed journals.

Agenda 49.53 was the information on development works completed by JSS AHER during 2017-19 which has been taken note of.

The Action Taken Report on the minutes of the 49th meeting of the Board of Management was considered and approved.

AGENDA No-50.03 : To consider the appointment of I/c. Vice Chancellor to JSS Academy of Higher Education & Research.

The I/c. Vice Chancellor briefed the members that pursuant to the completion of tenure of Dr. B. Suresh as Vice Chancellor of JSS AHER on 12.6.2019, the authorities of the Deemed to be University



constituted a Search-Cum-Selection committee for the selection of candidates for the appointment to the post of Vice Chancellor of JSS AHER. Accordingly, the said committee met on 23.4.2019 and submitted its recommendations to the Hon'ble Chancellor. In the meanwhile, in order to ensure smooth functioning of the deemed to be university, till the new Vice Chancellor is appointed and as per the provision contained in section 26 of the MOA of the Rules of the Deemed to be University, he has been directed to take charge as the I/c. Vice Chancellor until further orders vide orders of the University dated 12.6.2019 and hence reported for duty on 12.6.2019.

Sri Sathyam observed the delay in the appointment of Vice chancellor and Registrar and he suggested expediting the process of selection to ease the administration at JSS AHER.

Considered and noted the appointment of I/c. Vice Chancellor to JSS JSS Academy of Higher Education & Research, Mysuru.

AGENDA No-50.04 : To consider the appointment of Pro-Chancellor at JSS Academy of Higher Education & Research, Mysuru.

The Vice Chancellor briefed the members that the tenure of the second term as Vice Chancellor of Dr. B Suresh was completed on 11.6.2019 and he was appointed as the Pro-Chancellor of JSS Academy of Higher Education & Research. As per the said order, the Pro-Chancellor, Dr. B Suresh has assumed charge on 13th June 2019 and will be assisting the Hon'ble Chancellor in the functioning of the Deemed to be University. The Vice Chancellor also informed the members that under the MoA/Rules of JSS AHER, he has been nominated as the member of the Board of Management as the nominee of sponsoring society and requested the Pro-Chancellor to guide the Deemed to be University. Justice Sri Shivaraj Patil stated that the need for the creation of the post of Pro-Chancellor be clearly justified in the minutes.

The board considered the creation of the Post of PRO-CHANCELLOR, which was primarily due to the strides that the university has been taking in the last few years, besides the future plans that are proposed by the university including the development of the Varuna Campus. The Board also considered the appointment of Dr. B Suresh as the Pro-Chancellor at JSS Academy of Higher Education & Research, Mysuru.



AGENDA No. 50.05 To consider the constitution of Selection Committee for appointment to the post of Registrar of JSS AHER.

The Vice Chancellor briefed that the term of appointment of Registrar of Dr. B Manjunatha ended on 19.6.2019 and that the services of Dr. B Manjunatha as Registrar of JSS AHER was extended until further orders as per Sec.10.12.4(iii) of UGC (Institutions Deemed to be Universities) Regulations 2019 in the interest of the institution.

He then requested the board to nominate 4 members to the Selection committee as per regulation 2019 of MoA of the Deemed to be University.
