The Vice Chancellor seeking the blessings of His Holiness Swamiji, the Hon'ble Chancellor of this university, welcomed all the members to 60th meeting of the Board of Management and conveyed the blessings and the good wishes of His Holiness Swamiji. The Vice Chancellor also conveyed Dasara greetings to all the members.

The Vice Chancellor extended warm welcome to Hon'ble Justice Sri Shivaraj Patil, who was present online, Dr. C.G. Betsurmath, Executive Secretary of JSS Mahavidyapeetha, Pro-chancellor Dr B Suresh, Hon'ble members, Sri Sathyam, Dr Sachhidananda and Dr Girish Shah, who were present in person, Dr V M Katoch, who was online, Deans of Faculty, Principals of Constituent Colleges, Heads of Departments and officers of the Deemed to be University to the 60th meeting of the Vice-Chancellor informed the members that Board of Management. Dr. B. N. Gangadhar has informed his inability to attend due to unavoidable commitment.

The Vice Chancellor in his opening remarks informed the house that before taking up the agenda, he wanted to share certain good developments and said that in the Times Higher Education World University Rankings 2022 which were declared very recently, JSS AHER is ranked in the rank band of 351-400 and only three institutions from India are in top 500 and JSS AHER is one of them. JSS AHER is at No 2 position in India, sharing this position with IIT Ropar. Ahead of JSS AHER is only IISC, Bengaluru. Amongst the private Universities (Deemed to be Universities), JSS AHER is the only University within the top 500 and is among the world's best. This coveted achievement will help the university to continue with the graded autonomy of the Deemed to be University at Category-I status.



With regard to Times Higher Education World University Rankings by Subject 2022 for Physical Sciences, Life Sciences, Psychology and Clinical and Health disciplines, the Vice Chancellor informed the House that around 1,523 universities from 98 countries have ranked in at least one discipline and this year JSS AHER has made a place for itself in the top 100 World University Rankings by Subject 2022 by securing 93rd rank in the Clinical and Health discipline and first in India.

Speaking about the NIRF 2021 results which were released on 9.09.2021 by Hon'ble Minister of Education Shri Dharmendra Pradhan virtually, the Vice Chancellor was pleased to bring to the notice of the house that JSS AHER is ranked 34th among 1657 entries in the 'University Category' and ranked 56th among 6000 entries in 'Overall Category' thus sustaining position amongst top 50 universities in India for consecutive years from 2016-2021. He said that an analysis of the same will be made when the regular agendas are taken up.

The Vice Chancellor expressed his profound gratitude to His Holiness Swamiji, for his Vision, Leadership, Guidance and Constant encouragement to JSS AHER from time to time which has helped the university to achieve these achievements.

A quick brief on the WHO activities was also made by the Vice Chancellor for the information of the members. He said that there are three ongoing WHO projects, viz. cGMP Mentorship Pilot Programme, Web Training Series on Blood component & Plasma Fascination and In-Vitro Diagnostics. He also appraised about the release of grants by WHO for the said training programmes.

The Vice Chancellor also thanked the members of Board of Management, Planning and Monitoring Board, Academic Council for their guidance and support and also the constant support of JSS Mahavidyapeetha and the efforts by the Principals of the Constituent Colleges, Head of the Departments, and all the Teaching and Non -Teaching staff of JSS AHER for making this possible.

Continuing, the Vice Chancellor said that this meeting, apart from Action Taken Report on the 59th Board of Management meeting, MoUs and other regular agendas will also have the Minutes of the 33rd meeting of the Academic Council held on



9th April 2021, Minutes of the Ph.D, Selection Committee and Screening Committee, which are placed for kind perusal and approval. He further appraised the members that progress made on the Development of JSS AHER Global campus at Varuna along with a presentation on use of Artificial Intelligence at JSS AHER will be made today.

Before taking up his presentation and moving towards the agendas, the Vice-Chancellor once again welcomed all the members and requested them for their views or suggestions.

Justice Sri Shivaraj Patil in his remark said that he was very happy about the progress made by JSS AHER in improving its record and on behalf of members of the Board of Management appreciated and placed on record the efforts made by JSS AHER, with special reference to Pro-Chancellor, Vice Chancellor and their team also made a mention of **uLektz** Wall of Fame which has announced the **"Top 20 Eminent Vice Chancellors of India**" for the year 2020 wherein, Dr Surinder Singh, the Vice Chancellor of JSS AHER is one among them and said that JSS is proud of having the best Vice Chancellor and congratulated him.

Sri. Sathyam, congratulated the university and placed on record his appreciated the efforts put in. He also placed on record the appreciation for Dr. S. Balasubramanian, Director (Research), who had resigned recently for his contribution to the university.

Briefing about the Action taken report on the minutes of the 59th Meeting of the Board of Management, the Vice Chancellor said that minutes of the meeting have been communicated to all the members. As suggested earlier by Sri Shivaraj Patil, only agendas which require action have been segregated and placed for discussion.

Agenda 59.03 was confirmation of the minutes of the 32nd Meeting of the Academic council held on 9th April 2021. The approved new programs and amendments made to the proposed curriculum have been notified and circulated to all the stake holders.

Agenda 59.04 was the proposal for opening of FCRA A/c at SBI, New Delhi, Branch which is under process at Delhi Office and in another 2-3 months, this will be completed.

Agenda 59.06 was regarding considering the Data Management and sharing Policy of JSS Academy of Higher Education & Research and JSS Hospitals 2021. Members have given their concurrence and this matter will also be taken up at the next Governing Body meeting of JSS Hospital.

Agenda 59.11 to 59.17 related to various MoUs. All the MoUs have been signed except 3 MoUs, viz. Bangabandhu Sheikh Mujib Medical University, Bangladesh, University of Turin, Italy and IIT, Madras which are in the process. All the required documents have been sent in this regard.

Agenda 59.18 was regarding considering the reconstitution of the various Boards of Studies at JSS AHER. Dr Sacchidananda had desired that a separate Board of Studies for Medical Super Speciality subjects has to be constituted to monitor the super speciality programs. Vice Chancellor said that action is initiated and a separate agenda is placed today

Agenda 59.20 was regarding various research Projects submitted/sanctioned to constituent colleges and departments from different funding agencies from March 2021 to June 2021.

Agenda 59.21 related to the progress made on Development of JSS AHER global campus at Varuna. With regard to the suggestion of Sri Sathyam, the Vice Chancellor informed the house that provision for Sewage treatment plant has been planned in the Varuna Global Campus.



Agenda 59.22 was regarding the extension for empanelment of Dr Cariappa K M. as an Adjunct Faculty at JSS AHER. Sri Sathyam drew attention to his suggestion of critical review of the adjunct faculty for which Vice Chancellor informed that a format is developed and is placed at Annexure-2, for the perusal of Hon'ble members. Dr Sacchidananda suggested considering MD & PhD programme as an integrated programme and said that NMC has approved this and it would be better if JSS AHER considers this. Pro-Chancellor in reply said that till now there are no takers for this. However, now since NMC has taken up this, we may see how this can be compressed whether it is 4 years or 4 and half years, should be thought of and we need to work out certain acceptable norms with UGC. Dr Sacchidananda suggested to go for attractive schemes like appointing such scholars as Asst Professors or considering waiver in fee etc which may attract students. He also said that we should look into the gaps to improve our rankings and analyse why ranking could not be moved little high and in order to improve upon what are the methodologies required. He was of the view that MoU with Indian Institute of Science (IISc) may be good as they have the best facilities in the country and IISc is also planning to start Medical College in the near future. If approved, he said that he can initiate dialogue with IISc. Dr Basavanagowdappa said that there is one specific project MoU with IISC and we may plan to expand the scope of it as suggested by Dr. Sacchidanand.

Remaining actions have been initiated and hence Vice Chancellor requested to consider and approve the Action Taken Report on the minutes of the 59th meeting of the Board of Management meeting.

An update was given by the Pro-chancellor regarding Varuna global Campus. He said that all official formalities are done properly and every possible analysis, licence, permissions are taken care to avoid any challenges locally or from any government/political side. Required permissions would be obtained and are in pipeline and this will be ensured before it takes off in all respects. At this juncture Executive Secretary added that the plan of Dandikere village has been approved.



Justice Sri Shivaraj Patil too was of the opinion that all the required permissions, licences are obtained from competent authorities in order to avoid complications at a later stage.

Sri Sathyam asked about the sewage disposal and suggested that it would be better to have the concurrence of the Water Resources Department of the State.

Dr V M Katoch suggested to ensure care on discharges of periodical waste from labs.

Pro-Chancellor also brought before the house that two things are being introspected over the next 10-15 days. Since he was made incharge of Technical Institutions Division of JSS Science & Technology University, he would be trying to bring JSS AHER and JSS ST&U together and one such process is STU's plan to launch satellite project in space for medical applications.

The second, he said was Artificial Intelligence and Health which is also in the advanced stage. In this regard, elaborate discussions were held with Hon'ble Chancellor on what next step the university should take, whether it is off campus/off shore campus, which is under thought process. Similarly establishing other departments and one such is starting a programme in Science. Since JSS AHER is ranked in the top 100, the university can start programmes in Economics, Geogoly etc. For this, a vision is also being made. Once the pandemic is over, hopefully in the next meeting this will be deliberated further, he said.

Sri Sathyam suggested to (i) check with ISRO who are doing this satellite project (ii) Try to device satellites, which ISRO may permit, may be latitudinal or slightly higher altitude and some information may be obtained in this regard (iii) expansion of off-campus. He said that advantage of Category-I autonomy to be exploited to the full and best possible extent.

Justice Sri Shivaraj Patil said that both the thoughts are good and this may be crystallized and can be given appropriate shape.



Vice Chancellor drew members attention to the new area where JSS AHER is working and in this regard he requested Dr Vikram Patil to make presentation on Artificial Intelligence.

After the presentation by Dr Vikram Patil, Sri Sathyam, complimented Dr Patil and suggested a joint project for drug adulteration with JSS ST&U. He also made a mention about Google's CEO Mr Sunder Pitchai's AI initiatives which may be thought of seriously, at least by collecting data. Similarly, he also suggested to collect 4 or 5 documentaries associated with AI, its scope, advantatges etc and present the shows for student and faculty for awareness creation.

Dr Sacchidanand suggested to start research projects for UG students. He said that a particular focus be made on a particular disease eg: oncology or local relevant disease and collect data on particular disease which may be useful over a period of years.

Dr Basavanagowdappa said that similar exercise is being done for communicable and non communicable diseases in the district of Chamarajanagar. He also said that the suggestion to focus research at the UG level is a good one.

Dr V M Katoch suggested tohave interventional projects which will be having minimum cost as a model project.
