

(i) DED expressed that Sri Mahesh Basavanna, Net Zero Energy Expert, IFC- World Bank is having 24 years of experience in designing low energy and net zero energy buildings and he is working with IFC, World bank since 2010. He led the development of green building regulations for Jakarta, Indonesia and Colombia, South America. He is the co-developer of EDGE rating system and APEX cities program. As a director of McD BERL he worked on many large net zero buildings which includes IIM's IIT's, NLU, IIIT's, Infosys, Goldman sachs, Morgan stanley etc.

water reuse and recycling systems, Rainwater harvesting, hot water systems, Electrical- design approach consider the life-cycle cost analysis of designing energy efficient lighting, generation & electrical distribution systems as well as integrating renewable energy technologies into both residential and commercial buildings, Fire Safety- Fire safety consulting ensuring code compliance with all current laws and regulations along with performance-based design, passive fire protection, Active fire protection, Fire detection and alarm system, Fire Suppression, escape route planning, BMS, Access and CCTV Systems, Retrofit works, LCC and LCA Analysis for MEP Systems, Design Review. Company provides extensive knowledge of the green certification process from registration to certification.

In response to the above and regarding zero carbon, Company members expressed that one unit of electricity is equal to 1.01 kg Carbon dioxide. Individual normal house produce nearly 7.5 kg. carbon to the atmosphere. Construction and operation of buildings produce carbon. If it continues, in the future, it may affect the earth like flowing floods, global heating etc., To reduce carbon percentage globally, Paris Agreement has been made in which India is one of the signatory. It is estimated that By 2030, it should be zero



- (ii) Sri Autif Mohammad Sayyed leads International Finance Corporation's Green Building Program in South Asia, where he has helped develop IFC's EDGE system as the fastest growing green building rating system, facilitated more than USD 800 Million of IFC's green building investments to developers, companies, and financial institutions across various parts of Asia. - 3. The members present in the meeting introduced themselves.
- 4. (i) Sri Mahesh Basavanna and Sri Autif Mohammad Sayyed presented PPT about their performances for company designs and expressed that their company is designing low energy and net zero buildings in consultation with World Bank.
 - (ii) They said that the company established with Mission "Leading the world's change from buildings to net positive built environment" through clean air, zero carbon, net positive water and energy buildings. It provides Green certification, building compliance, sustainability, net positive energy and water, and MEP design services for built environment. The firm considers every project as unique, rationalize and develop. It delivers services through inhouse built technology and tools, work with industry leaders and develop futuristic and resilient technology solution Services/Expertise. Provides Green certification and Regulatory Compliance, Sustainable & Net Positive Building Design, Building Engineering Services(MEPF) Services/Expertise. Facilitate modern principles, including digital design, occupant-centric design, biophilic design principles and design for carbon neutrality.
 - (iii) Company services includes Micro and Macro Climatic Analysis, Wind Flow Analysis, Shading, Massing, Daylight, Glare and Lighting Simulation, Facade Optimization & Panelization, Energy Modelling & Sensitivity Analysis, Passive Design, Thermal Comfort Studies, Sustainable Master planning, Computational Fluid Dynamics(CFD), Health and Well-Being, Water Self Sustainable Development & SUDS Design, Renewable Energy & System design, Mechanical design solutions in all aspects such as economical, eco-friendly, Energy efficient, low operating cost and easy to maintain cooling and Heating systems, Plumbing design- water conservation strategies that can be employed to reduce the amount of water consumed at a facility which includes efficient water system design, water conservation measures,



carbon, By 2050 focus on net zero carbon. There is a need to take action to make zero carbon buildings from now itself. Glass buildings are not suitable to Indian conditions. In future Government may move forward like impose penalty for old buildings, cutting subsidies for non-zero carbon buildings. It is targeted to achieve zero carbon by 2030. The company has designed for so many zero carbon buildings in which innovative steps are adopted such as using hydrophonic system for production of food, innovative cooling system, blind free, radient cooling system etc., Government supports these zero carbon buildings like giving subsidies etc.,

Further the Company members said that, to assess buildings for zero carbon, some procedure are to be followed like verifying construction material used, kind of construction, windows and ventilators provided, water supply arrangements made, Rain water harvesting, AC, lightings, switch controls, fans, etc., This information to be analysed through online software and ascertained for zero carobon grade. Analysis sent to Third party certification for issue of certificate after analysing building efficiency. Required suggestions/alterations will be issued for improvising the buildings. There will be some fees for Third party certification. Designs will be made for both old and new buildings. Phasewise upgradation will be suggested. (For example changing of windows, ventilators, chillers, Changing of lights, control switches, putting solar panels etc.,). The whole campus will be considered as one unit. Already these zero carbon building designs are made for some of old buildings and presently they are at good results. In this regard, the Government is offering tax incentives, subsidies, selling carbon credits etc. for zero carbon buildings. Some of the State Governments have made MOUs with World Bank in this regard. Courses for students have been started to create awareness regarding zero carbon buildings. The Company members also said that it will be verified regarding acceptance of Third party Certification by NAAC/UGC accreditation.

After discussions following points are directed by His Holiness.

- To have inspection of JSS Institution campus, Saraswathipuram, Mysuru and JSS Pharmacy college campus, Mysuru along with the Company members for selecting as one of the campus for rating.
- 2. To share all the data required for rating the selected campus.
- To conduct meeting with Architects and Company Members for Varuna project which is at architectural planning stage.
