Subject: Grant of Central Government permission for starting of MDS course in one speciality and increase of seats in MDS course in six specialities at J.S.S. Dental College & Hospital, Mysore, from the academic session 2012-13.

Sir,

I am directed to refer to your letter dated 02.04.2012 accepting the terms and conditions contained in this Ministry's letter of even number dated 23.03.2012 and furnishing therewith a Performance Bank Guarantee bearing No. 02/2011-12 dated 31.03.2012 for Rs.100.00 lakhs issued by State Bank of Mysore, Shivarathreeshwarnagara, Mysore, Karnataka, and to convey the formal permission of the Central Government under section 10A (4) of the Dentists (Amendment) Act, 1993 to J.S.S. Dental College & Hospital, Mysore, Karnataka, for starting of MDS course in the speciality of Oral Pathology & Microbiology with 2 seats and increase of seats in MDS course in the specialities of (i) Paedodontics and Preventive Dentistry from 3 to 4 seats (ii) Conservative Dentistry & Endodontics from 3 to 5 seats (iii) Orthodontics & Dentofacial Orthopedics from 3 to 4 seats (iv) Periodontology from 3 to 4 seats (v) Oral & Maxillofacial Surgery from 3 to 4 seats (vi) Oral Medicine & Radiology from 2 to 4 seats from the academic year 2012-13.

2. The admission of next batch of students in MDS course in the above specialities with normal intake capacity and with increase of seats for the academic year 2013-14 will be made only after obtaining the renewal permission from the Central Government.

3. In case any admissions are made in violation of the above condition will be treated as irregular and action under Section 10B of the Dentists (Amendment) Act, 1993 will be initiated.
