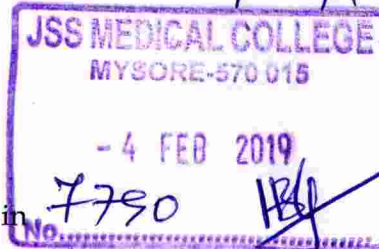

Subject: Increase of seats in various postgraduate degree courses in lieu of surrender of concerned diploma seats at JSS Medical College, Mysore prospectively i.e. from the academic session 2019-2020-reg.

Sir/Madam,

I am directed to state that the Board of Governors considered the matter with regard to increase of seats in various postgraduate degree courses in lieu of surrender of concerned diploma seats at **JSS Medical College, Mysore** along with the request of the institute received through Central Govt. after notification dated 12/07/2018 as well as the recommendations of the PG Expert Group (BoG) on the basis of information furnished by the institute(s) as desired by the Council and noted that the request for conversion of diploma seats into corresponding degree seats and de-notification of Diploma seat(s) was received through the Central Government after notification dated 12/07/2018.

In view of above, the Board of Governors decided to allow conversion of the following diploma seats into corresponding recognized degree seats prospectively i.e. from the academic session 2019-2020 as under:-

8	MD (Anaesthesia) - 8	DA - 4	8 to 12
