In this regard, kind attention is invited to your letter dated 19.02.2019 informing therein as under: -

"There were no Post Graduate students admission to MD (Anatomy) from the academic year 2012-13 and MD (Physiology) from the academic year 2013-14. Hence, no Post Graduate students will be appearing for exam in April/May 2019.

No students have been admitted to MD (Biochemistry) for the academic year 2016-17. Hence, no post Graduate students will appear for the examination during April/May 2019 for MD (Biochemistry).

However we wish to renew the PG Course recognition in the above said courses."

In this connection, your kind attention is invited to Sections 6 (4), 6 (5) & 6 (6) of Postgraduate Medical Education Regulations, 2000 as amended by amendment notification" Postgraduate Medical Education (Amendment) Regulations, 2009 Part-II" dt. 21/07/2009 and act appropriately at appropriate time which read as under:

"6. ..

(4) The recognition so granted to a Post Graduate Course shall be for a maximum period of 5 years, upon which it shall have to be renewed.

(5) The procedure for Renewal of recognition shall be same as applicable for the Award of recognition.

(6) Failure to seek timely renewal of recognition as required in sub-clause-4 shall invariably result in stoppage of admissions to the concerned Post Graduate course....."

The matter has been reviewed by the Competent Authorities and noted that no students will be appearing for examination in April/May 2019 in the above mentioned 03 subjects and further noted that renewal of recognition assessment has to be carry out at time of practical examination in terms of Govt. Gazette Notification dated 21.07.2009.

Under these circumstances, it has been decided to advise to college authorities to apply for renewal of recognition in respect of above 03 subjects at the time of next practical examination.
