I am directed to state that the Board of Governors considered the Assessment Report (13.05.2019) on the standard of examination and other teaching facilities available at J.S.S. Medical College, Mysore for purpose of Renewal of recognition of MD(Anaesthesia) qualification for 08 seats granted by JSS Academy of Higher Education & Research (Formerly knows as JSS University) and decided as under: -

"The Board of Governors considered the Council Assessor's Report (13.05.2019) together with the recommendations of the PG Expert Group (BoG) and decided to recommend to the Central Government that the recognition of MD(Anaesthesia) qualification for 08 seats granted by JSS Academy of Higher Education & Research (Formerly knows as JSS University) in respect of students being trained at J.S.S. Medical College, Mysore be renewed.

The Board of Governors further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."
