 - a. Grade the severity of all the reported chemotherapy related adverse events as per Common Terminology Criteria for Adverse Events (CTCAE).
 - b. Incorporate the contact number of adverse drug reaction monitoring centre (AMC) and Pharmacovigilance Program of India (PvPI) in outpatient prescriptions so as to ease the process of consumer reporting.
 - c. Present the trend analysis of safety data.
